Group Membership Application Form

Group Membership to the Angling Coaches Association is open to any licenced angling coach within the United Kingdom who works for or alongside a current active full member of the Association (Group Members Sponsor Coach).

Important Notes

Group Membership is only valid whilst the Group Members Sponsor Coach is a current and compliant member of the Angling Coaches Association. A sponsor Coach can only have a maximum of 10 Group Members under their membership registration.

Member coaches can only undertake coaching as a ACA member whilst they are fully compliant with the licencing requirements of their governing body. It is a mandatory requirement of our member coaches to ensure that any requirements associated with their coach licencing scheme are strictly adhered to (current criminal record check, valid first aid qualification, current child protection training etc.).

Membership of the Angling Coaches Association is automatically voided where a member no longer holds a valid coach licence including associated licence requirements.

As a member of the Angling Coaches Association, we expect our members to demonstrate best practice and confirm their validity to coach to any student by supplying copies of licences and supporting certification on or before their first coaching session.

ACA members must always comply with all local laws and byelaws ensuring that they and their students hold all required licences and permits for angling.

If, for and reason, the members licence to practice is suspended or rescinded by their governing body, membership of the Angling Coaches Association will be similarly suspended or terminated. It is the members responsibility to immediately inform the ACA of such occurrences.

Membership of the Angling Coaches Association is based on a rolling 12-month period from the month following the original acceptance of application.

Group Members have certain restrictions/exclusions compared to full membership benefits.

- Business Advice Services - Excluded
- Find a coach service registration - Excluded.
- Compliance Reminder Service – Excluded
- Annual tackle benefits cap – £500 (net) expenditure per annum
