Applications for membership are only available to holders of a valid coaching licence issued by a recognised Governing Body (Angling Trust for England, Angling Development Board of Scotland, Angling Cymru for Wales, Angling Council for Ireland).

Important Notes

Member coaches can only undertake coaching as a ACA member whilst they are fully compliant with the licencing requirements of their governing body. It is a mandatory requirement of our member coaches to ensure that any requirements associated with their coach licencing scheme are strictly adhered to (current criminal record check, valid first aid qualification, current child protection training etc.).

As a member of the Angling Coaches Association, we expect our members to demonstrate best practice and confirm their validity to coach to any student by supplying copies of licences and supporting certification on or before their first coaching session.

ACA members must always comply with all local laws and byelaws ensuring that they and their students hold all required licences and permits for angling.

If, for and reason, the members licence to practice is suspended or rescinded by their governing body, membership of the Angling Coaches Association will be similarly suspended or terminated. It is the members responsibility to immediately inform the ACA of such occurrences.

Membership of the Angling Coaches Association is based on a rolling 12-month period from the month following the original acceptance of application.
